Affiliation Facilities within the British Wado Federation & British Wadokai

Types of Membership:

- 1. **Full Member (British Wadokai):** Club Level. Directly controlled by British Wadokai and Chief Instructor (including Constitution, Syllabus, Licence control, UK Insurances, etc.), Yudansha-No-Iinkai. Members will also be registered and have access to various British Wado Federation facilities.
- 2. Direct Member (British Wadokai): For Associations, Groups and International Memberships that have a 'Regional' or 'International' Senior Instructor. Directly controlled by British Wadokai and Chief Instructor (including Constitution, Syllabus, Licence control, UK Insurances, etc.), Yudansha-No-Iinkai. National Members will also be registered and have access to various British & International Wado Federation facilities. International Members must seek their own national insurance and be affiliated to a 'National Governing Body', of their Country.

British Wadokai Club Insurance for £5m Public Liability is *FREE* and is included in Full/Direct UK Affiliation Membership.

TERMS OF INSURANCE FOR FULL/DIRECT MEMBERS (UK): British Wadokai Club Affiliation Insurances extends only to clubs who are affiliated and have officially registered BWK Instructors (i.e. those who possess a minimum grade of a Full **1st Dan**, a BWK Issued **Instructor Certification**, **Enhanced CRB** (activity specific and issued by the BWK), **Instructors Insurances**, and **1st Aid Certification**, **Child Protection Awareness Certificate**).

UK British Wadokai Clubs are not insured to have non-BWK Instructors teaching at their Dojo, all visiting instructors must be in possession of their own Instructor/Freelance Insurances and qualifications that cover teaching BWK membership under their tuition and responsibility. Also, Club Insurance does not cover Kick-boxing or bladed weapon training.

Abuse Cover	£5 million	Excluded by majority of liability policies
Tournament Liability Cover	£5 million	Cover for British Wadokai & British Wado Federation events.
